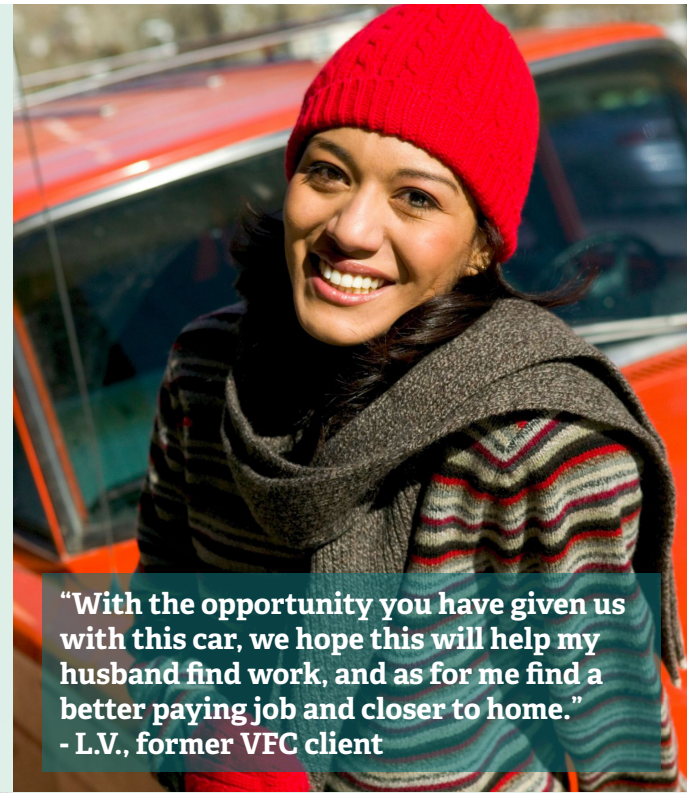

About NVFS Vehicles for Change

Vehicles for Change receives donations of used cars from the community, determines whether the cars are repairable, and prepares them to be road-ready. In exchange, recipients are responsible for a car payment of \$800. Each vehicle comes with a six-month, 6,000-mile warranty and AAA membership. Families are responsible for a deposit, car insurance, taxes, tags and title fees.

Recipients are low-income families who need a vehicle to get to work and perform daily functions such as getting children to daycare, school and medical appointments.

Eligibility

- Income 200% or less of poverty level
- Current or former TANF recipient
- Employed at least 30 hours per week for 30 days
- At least one dependent child under 18
- Valid Virginia driver’s license
- Proof of no DWI by obtaining a DMV driving record for all adult drivers in household
- All bankruptcies must be discharged
- Savings of at least \$250
- Sufficient disposable income to maintain a monthly car payment
- Insurable
- Owns no other car nor has one available
- Drug-free and without a criminal record
- May access VFC only once



Program partners include Vehicles for Change (Baltimore, Md.) and the Virginia Department of Social Services.

Requirements

- Able to take a short-term loan to cover costs associated with the car
- Attend Car Orientation program prior to receiving car
- Can budget ongoing expense of car insurance, including collision coverage
